DEFENCE OF THE METROJAYA 25

The 25 Bast Timorese still being held in Metro Jaya Jakarta are to be defended by 19 different teams of lawyer, according to Luhut from LBH who is co-ordinating their defence. This is because their will be 19 different trials, he said. Each trial will require a team of 1-3 lawyers to defend the accused. LBH has insufficinet human resources to fulfil the task, itself be requesting the assistance of the Indonesian will Association.. As repeted in previous BTT's, the dossiers of the 25 have already been passed on to the Public Prosecutor's Office for processing. Once the charges are formulated they will then be passed to the court. While the Bali 4 are to be charged with subversion the remaining 21 are accused of insulting the state and disturbing public order as according to articles 154 and 155. Following interrogations, the Bali 4 have been branded as being at the centre of the East Timorese resistance network in Indonesia (outside of East Timor itself), and John Camaro, his detention kept in an isolated cell, has been 'identified' as co-ordinator for Jakarta. Despite such 'discoveries', interrogations are continuing. It seems likely therefore that the original military version of evidence against the accused as passed to the Public Prosecutors, may be softened due to Suharto's intervention. When asked of the situation of those detained in Dill. Luhut said that although LBH had sent a team there to complie a report on the 12 November affair and subsequent events, LBH does not have a branch in Dili and is not handling the cases of the Dili prisoners. He doubted whether they were receiving any legal help at all.

tortured, LBH saw no sign of this and, according to Luhut, the 4 "were smiling" when they met with the lawyers.

INFIGHT'S RESPONSE TO THE RESULTS OF THE NATIONAL INVESTIGATING TRAM (KPN)

On December 27 1991 the National Investigative Committee (KPN) announced the results of its investigation into the 12 November Affair. Infight considers the report of a serious effort to uncover the real train of events connected with the affair. That the report differs from the official ABRI (Try Sutrisno) version is a departure from the norm. In the cases of Malari, Tanjung Priok, Aceh, Lampung, and the (petrus) mysterious killings we have been expected to accept the official (ABRI) figure put on the numbers of victims, which without fail has fallen well short of the actual figure.

Nevertheless, Infight regrets that the formation of the KPN was merely a response to international pressure and that its investigation was conducted at atime when the East Timorese community was too araid to speak out. Whilst the report surpassed expectations by showing the government's courage to admit to human right's disasters, it did fail to detail the actual train of events of the incident. Thus a neutral comission under the

auspices of the United Nations remains a necessity.

INFIGHT hopes the KPN reprt will mark the end to the military tradition of seeking violent solutions to political issues. The fact remains that the 12 Novemebr incdent represents violation of the basic human right to freedom of expression. That in the final analysis the military's response to the demonstration was vilent and it is such violence that must not be repeated.

INFIGHT demands that the following actions be taken

follow-up to the KPN report:

1. A guarantee that human rights in Indonesia will be inthe future upheld, in particular that criticism, in the form demonstations, directed at the government, will no longer dealt with in a violent manner

2. That the role of the military is limited to security such that the military no longer needs to justify its violent actions by saying its personnel were 'provoked', or to defend itself in a way that is not in keeping with the role of ABRI as national

patriot.

As stated by the KPN report several members of the security apparatus who opened fire on the crowd of demonstrators were acting beyond their command. Those East Timorese detained as result of the various prologues and epilogues of the 12 November Affair must therefore be released since they are only the victims of the irresponsible actions of certain elemnts within the military.

4. That the formation of ademocratic poilitical system as in accordance with the principles of human rights in East Timor in particular as well as in Indonesia as a whole is formed because

PANJAITAN APOLOGISES

installation ceremony of Gen. Theo Safei, to replace Panjaitan ans Udayana Regional Commander, and H.B.L. Gen. Mantiri, to replace Waouw as Commander of Operations in East Timor, took place yesterday in Dili. The ceremony included a farewell speech by the outgoing Panjaitan, who expressed regret and apologised for the misdeeds and shortcomings of ABRI members. He said he hoped that the 12 November Dili Incident would not be repeated. Panjaitan installed Safie to replace Warouw, whilst Try Sutrismo installed Mantiri. Attending ceremony were Sutrisno, Edy Sudrajat, enny Moerdani, Carrascaloa and Bishop Belo. Both Mantiri and Syafei are East Timorese veterans. Safei expressed his intention to hold discussions with youths to find out their asspirations, and said that the military approach must differ to that of the late 1970's.

DEATH OF AN OLD COMRADE

An ex-Fretelin Commander Porforio, known as Maukloa by his friends, died on January 7 1992 in Gatot Subroto hospital, Jakarta, after suffering from heart and kidney complants. Maoklao was placed in hospital after hearing of th November 12 maasacre. Friends day he suffered severe shock as a result of the news.
